
Orientation map of HS2019

n) emergency procedures,

During the event there is ensured fire and medical emergency which is completely in accordance with directive for organisation of public events.

In case of emergency procedures pilots-in-command are obliged to keep the distance from visitors according to article f/ of this briefing, in case of the necessity to prevent harming visitors on ground at a maximum possible way. In regards to the situations which need to follow the emergency procedures, this needs to be done at the height at minimum of 1000 FT AGL or under the bottom base of clouds.

#### r) obligations for exhibiting aircraft at the air show

The exhibiting aircraft are obliged to:

- a) fly as the exhibiting aircraft is flying around display line or the direction from visitors; not to perform any low pass with sudden (sharp) turns close to the display line, the aircraft is not allowed to disturb distance given in this briefing
- b) stick to the display line and demonstration area,
- c) take part in pre-flight briefing
- d) when asked, provide to the Flying Display Director or to CAA's inspector for control the required documents (pilot documentation pilot licence including valid medical licence, in case the medical licence is not part of the pilot licence, log book, permission to demonstrate the exhibition flight, aircraft documents Airworthiness certificate, Certificate of Registration, Aircraft Station Licence, Maintenance Certificate, Insurance certificate, eventually based on the before mentioned announcement all other documentation of pilot or aircraft which are required by CAA or Flying Display Director), e) keep the demonstration variant according to Description of exhibition approved by quarantor of the flying display or approved person, including all limitations,

- f) ensure that on board of each aircraft are only persons who are namely stated in the Description of the exhibition,
- g) respect the instruction given by the Flying Display Director,
- h) respect the instruction given by AFIS,
- i) helicopter pilots are obliged to take in consideration during their flying the rotor flow so they do not endanger the visitors and property on ground; for the flights with cargo they are obliged to consider the safety and fly only over the obstacle-free area,
